On behalf of the Secondary Education program, I submit two Course Change Proposals for EDTE 402 and 402P so as to change both course designators to EDSE.

EDTE 402/402P were required courses in the Early Childhood and Elementary 5<sup>th</sup>-Year MAT programs, but now these courses are required solely for admission to the Secondary Education MT as well as for undergraduate programs in Art, Music and Business Education. Currently only the Secondary Education program in the College of Education requires EDTE 402 and 402P within a degree. These courses are required for all undergraduates majoring in areas that lead to admission to the MT program in English, Mathematics, Science and Social Studies. The course and practicum now focus exclusively on grades 9-12 teaching, different from when they were initiated and required in the Early Childhood and Elementary MAT programs.

The Secondary Education program is preparing a proposal to change the course designators of EDTE 402/402P to EDSE to more clearly reflect the secondary education focus. We may also revise the course descriptions.

First, we want those of you leading K-12 and 7-12 programs to be aware of this grade level emphasis change. We will support any proposals you might have to create a new version of 402 unique to your teacher candidates (and staffed by your faculty), or, if you feel the course is no longer useful to your program, we will support deletion of the course requirement(s). Some of your programs do not require 402P, but be aware that the practicum is a co-requisite that will be enforced in the future (by 2011-2012) and for all applying for admission to the MT in 2010-2011.

Please let me know if you concur with our proposal to change the designator to EDSE or if these changes pose any concerns that will impact your programs negatively. The Secondary Education program will be happy to discuss concerns you might have and seek mutually agreeable solutions.

Currently only the Secondary Education program in the College of Education requires EDTE 402 and 402P within a degree. These courses are required for all undergraduates majoring in areas that lead to admission to the MT program in English, Mathematics, Science and Social Studies. The course and practicum now focus exclusively on grades 9-12 teaching, different from when they were initiated and required in the Early Childhood and Elementary MT programs.

We will support any proposals you might have to create a new version of 402 unique to your teacher candidates (and staffed by your faculty), or, if you feel the current course is no longer useful to your program, we will support deletion of the course requirement(s). Some of your programs do not require 402P, but be aware that the practicum is a co-requisite that will be enforced in the future (by 2011-2012) and for all students applying for admission to the MT in 2010-2011.
